

# Capitol Imaging Continues Houston Market Expansion with Acquisition of Houston MRI

Clearview Capital Fund IV, L.P. and its affiliates (“Fund IV”) announced today the acquisition of DRH & Associates, Inc. d/b/a Houston MRI & Diagnostic Imaging (“Houston MRI”) by its portfolio company Capitol Imaging Services, LLC (“Capitol Imaging” or the “Company”). The transaction closed on January 3, 2025.

Houston MRI offers a full range of diagnostic imaging services and operates seven locations in the Greater Houston area. As a premier provider of outpatient diagnostic imaging services, the broader Capitol Imaging platform offers patients a range of modality capabilities, including MRI, CT, PET/CT and mammography scans, among others.

Capitol Imaging, in partnership with Clearview Capital, has expanded from 20 freestanding outpatient imaging locations in 2020 to 48 facilities across Texas, Louisiana, Alabama, Mississippi and Florida. The Company now has 18 total centers in the Greater Houston area.
