

## *Clearview Capital's OVS pumps up (again) with the acquisition of Davis Pump & Electric Motors*

**Stamford, CT, January 20, 2021** — Clearview Capital Fund III, LP ("Fund III") announced today the acquisition of Davis Pump & Electric Motors, Inc. ("Davis") by its portfolio company, Orchard & Vineyard Supply ("OVS"). The transaction closed on December 18, 2020.

Davis is a leading full-service provider of water pump installation and repair services serving orchards, vineyards, and other end markets throughout the state of Washington.

OVS is a leading agricultural solutions provider offering a broad range of trellis and fabrics systems, irrigation and water systems, agronomy, and farm management services. OVS' mission is to be a value-added partner and a "one-stop shop" for growers of high-value, permanent crops.

OVS was formed through Fund III's initial acquisition of Wilson Orchard & Vineyard Supply (based in Yakima, Washington), in partnership with management, from a passive owner in 2016, and subsequent merger with Oregon Vineyard Supply, which had been an ESOP, in 2018.

Today, OVS is headquartered in McMinnville, Oregon and operates out of eighteen locations in Washington, Oregon, California and New York. OVS also services growers nationwide through its e-commerce platform, [www.orchardvalleysupply.com](http://www.orchardvalleysupply.com).

Davis' owners, Scott and Darin Davis, will continue to manage the operations of Davis as the Washington division of OVS' Pump & Water Systems business. "I'm excited to be joining a larger organization like OVS," said Scott. "Partnering with OVS will allow me to focus more of my time on working with clients to offer a more comprehensive suite of services."

"The acquisition of Davis aligns well with Cascade Water Systems, acquired in July 2020," added Jason Luster, OVS' CEO. "The addition of Davis further enhances OVS' position as the leading provider of innovative irrigation and pumping solutions to the specialty agricultural market in the Pacific Northwest."

"Davis represents OVS' sixth acquisition since our original investment in Wilson," said Matt Rumilly, Partner at Clearview Capital. "The investment in Davis is a continued commitment to expanding service offerings for our customers."

Clearview Capital Fund III, LP is a \$325 million committed fund raised in 2013.
